5. **Entries** : Preliminary entry (by event and numbers) – **Form MFF 1** .
This form has to be received by the organizing committee
not later than **6th July 2015**.

Final entry (by name) – **Form MFF 3A, MFF 3B** and form **MFF 3C**.
These three forms have to reach the organizing committee not later
than **1st August 2015**.

6. **Competition Rules** : The fencing competition shall be conducted in accordance with the current statues and rules of FIE. In case of disagreements in interpretation of the rules, the latest FIE rules in the English version shall prevail. The Directoire de' Technique shall deal with any unforeseen incidents not covered by the rules.
7. **Equipment** : FIE equipments are not compulsory, however, rusty weapons, torn fencing attire and short socks are not allowed. Fencer's clothing must be made of sufficiently, robust material and should be in good condition. **An inner plastron is compulsory**. Weapon check will be done on the piste before each bout.
8. **Competition Management** :

(8.1) Referee

Participating delegations must be accompanied by number of referees according to the FIE Rules as follows :

1 – 4 fencers	: 0 referee
5 – 9 fencers	: 1 referee
10 or more fencers	: 2 referees

FOR MALAYSIAN ENTRIES

Note : Please ensure that the referees are to be properly attired.
Please bring a jacket / blazer and long pants.

****If the participating delegation fails to provide the required number of referees, a penalty fee of RM300.00 / per day / per referee will be imposed. The fee should be payed before the start of the competition on the day****

(8.2) **Directoire de Technique (DT)**

The DT will be responsible for the technical organisation of the competition.

(8.3) **Jury of appeal**

The jury of appeal will consist of one representative for each participating country / state / club under the chairmanship of the Organising Chairman, or a representative appointed by him. The decision of the jury of appeal shall be final.

(8.4) **Protests**

Appeals against decisions of the referee should be immediately made by the competitors to the referee, before any decisions are made regarding the subsequent hit. If the referee could not maintain his decision, the complaint will be brought to the attention of the D.T. Every appeal to the jury of hit appeal must be accompanied by a deposit of RM500.00 which will not be refundable. This sum will be confiscated in whole or in part if the appeal is rejected by jury of appeal. Appeals must be lodged and written in Bahasa Malaysia and / or English.

9. Prizes : **A medal will be awarded to the 1st, 2nd and joint 3rd places in each event.** **For each individual category of which the number of participants exceeds 64 fencers, a special prize amounting to **USD700** shall be awarded to the **gold medallist only**. **This is only applicable for the individual event participants solely.** **

10. Entry Fees : Individual Event - **RM 100.00 per person / per event.**
Team Event - **RM 300.00 per team / per event.**
Entry fees can be paid during the team manager's meeting by **cash**. **Kindly be reminded that all fees must be paid before the start of the competition.**
